- These are deferred shares originally granted under AMR's 2007/2009 Performance Share Plan. The AMR Board's Compensation Committee determined on April 21, 2010 that the performance criteria under the plan were achieved at 25%, and thus 25% of the initial grant vested on April 21, 2010. At the time of the initial grant, the number of shares reported was the target award (or 100%). The securities reflected in this column, equal to 75% of the shares initially granted, were therefore forfeited.
