AMERICAN AIRLINES GROUP REPORTS JUNE TRAFFIC RESULTS

FORT WORTH, Texas - American Airlines Group (NASDAQ: AAL) today reported June 2015 and year-to-date traffic results.

American Airlines Group's total revenue passenger miles (RPMs) for the month were 20.4 billion, up 2.8 percent versus June 2014. Total capacity was 23.9 billion available seat miles (ASMs), up 2.4 percent versus June 2014. Total passenger load factor was 85.4 percent, up 0.4 percentage points versus June 2014.

The Company continues to expect its second quarter 2015 consolidated passenger revenue per available seat mile (PRASM) to be down approximately six to eight percent year-over-year. In addition, the Company continues to expect its second quarter pretax margin excluding special items to be between 16 and 18 percent. For more financial forecasting detail, please refer to the Company's investor relations update also filed this morning on SEC Form 8-K.

The following summarizes American Airlines Group traffic results for the month and year-to-date ended June 30, 2015 and 2014, consisting of mainline-operated flights, wholly owned regional subsidiaries and operating results from capacity purchase agreements.
